Personal data that we process.

WSG Paragon processes your data because you use our services and/or because you provide them to us yourself. Below you will find an overview of the personal data that we process:

- First and last name
- Date of birth
- Address
- Telephone number
- E-mail address

In addition, any information you provide by completing surveys during your membership.

Special and/or sensitive personal data that we process.

Our website and/or service does not intend to collect data about website visitors who are younger than 16 years of age unless they have permission from parents or guardians. However, we cannot check whether a visitor is older than 16 years of age. We, therefore, advise parents to be involved in the online activities of their children, to prevent data about children from being collected without parental consent. For what purpose and on what basis we process personal data

WSG Paragon processes your data for the following purposes.

- Address -> For events and mail
- Phone number -> The use of WhatsApp and/or signal is our main way of communication.

- E-mail address -> To receive newsletters.

Automated decision making

WSG Paragon does not make decisions based on automated processing on matters that can have (significant) consequences for people. This concerns decisions that are made about computer programs or systems, without involving a person (for example an employee of WSG Paragon).

How long we keep personal data.

WSG Paragon does not store your data for longer than is strictly necessary to realize the purposes for which your data is collected. We use the following retention periods for the following (categories) of personal data:

Name & email: Stored in alumni registry until request for deletion;

Other personal data: 1 year after the cancellation of membership;

Payment details: 1 year after the cancellation of membership.

Sharing personal data with third parties

WSG Paragon only provides to third parties if this is necessary for the execution of our agreement with you or to comply with a legal obligation. If personal data must be shared for other circumstances, this will first be agreed upon with the members in a general meeting.

Cookies, or similar techniques, that we use.

The WSG Paragon website has cookies, but these can be rejected when first entering the website. There is no further tracking of personal data.

View, modify or delete data.

You have the right to view, correct or delete your data. In addition, you have the right to withdraw your consent to the data processing or to object to the processing of your data by WSG paragon. You also have the right to data portability, which means that you can submit a request to us to send the personal data we have about you in a computer file to you or another organization mentioned by you. You can send a request for access, correction, deletion, data transfer of your data or request for withdrawal of your consent or objection to the processing of your data to wsgparagon@gmail.com or fill in the contact form on the website.
